DRAFT Enrolment Scheme

(to take effect January 2020)



The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below and/or shown on the attached map shall be entitled to enrol at the school.

The Glenfield Intermediate School Home Zone:

Starting at the intersection of Wairau Road and Tristram Avenue (excluded) travel south along Wairau Road to Porana Road then travel across country to the Takapuna Golf Course. Travel along the boundary of the Takapuna Golf Course and then across country to Benders Avenue. Travel south west along Benders Avenue (Sunnybrae Road addresses 72-132 and 101-179 included) and then Coronation Road (Tye Road, Hillcrest Avenue and Nicholson Place, Stanaway Street, Lynden Avenue and Mountbatten Avenue excluded) to the roundabout. At the roundabout follow the boundary of the Birkenhead Domain and Eskdale Bush Scenic Reserve to the Waitemata Harbour Inlet. Continue to follow the Waitemata Harbour Inlet boundary then across country to Hotspur Place. Travel east along Hotspur Place and then north then east along Hale Crescent to Lynn Road. Continue north east along Lynn Road to the end of Glendhu Road and then across country to Glendhu Road. Continue north east along Glendhu Road (Hazel Glen included) to Sunset Road (excluded). Travel east along Sunset Road to Trias Road. Travel west along Trias Road (all addresses included) to Athena Drive. Follow Athena Drive (Remus Place included) at the end of Athena Drive travel east along Trias Road to Totaravale Drive (all addresses included). Continue south along Totaravale Drive to the roundabout (Sunnynook Road, addresses 174 and above included). From the roundabout go onto Link Drive and continue south to Crofffield Lane and then south all the way to Tristram Avenue (excluded) and then west back to the starting point.

Proof of residence within the home zone will be required.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

Special Programmes

Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

First Priority will be given to students who have been accepted for enrolment in the following special programme(s) run by the school and approved by the Secretary for Education. **

Second Priority will be given to applicants who are siblings of current students.

Third Priority will be given to applicants who are siblings of former students.

Fourth Priority will be given to any applicant who is a child of a former student of the school.

Fifth Priority will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.

Sixth Priority will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth, or sixth priority groups than there are places available, selection within the priority group must be by ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.
